Dear Riparian Owner,

On behalf of the applicant, Mariaville Lake Civic Association, an updated treatment plan for invasive nuisance plants and algae within Mariaville Lake is proposed for 2025. This notice is to inform you to disregard previously proposed treatments for Mariaville Lake sent by Little Bear's Affiliate Partner company Water & Wetland.

The updated treatment plan is as follows for 2025, two Article 15 AQV Aquatic Pesticide Permit application packages were submitted to the New York State Department of Environmental Conservation (NYSDEC) Region 4 Bureau of Pesticides.

Little Bear Environmental Consulting, LLC., a pesticide business registered with the New York State Department of Environmental Conservation (#18403) requested the approval of:

- a single application of Nautique, anticipated to occur between May 1st and September 30th, 2025.
- a single application of ProcellaCOR EC, anticipated to occur between May 1st and September 30th, 2025.

Water use restrictions for Mariaville Lake and South Chuctanunda Creek to the Confluence with Route 159 associated with the treatment are as follows:

LBE will collect water samples to determine when ProcellaCOR concentrations are less than 1ppb. This is anticipated to take 48 hours following the treatment to lift the water use restrictions.
