3. No vessels other than those owned by the resident and listed herein may use this launch facility. Upon sale of vessels listed herein the resident shall contact JAZ Property Management to update this agreement. Prior to launch of any additional vessels owned by the resident, the resident shall contact JAZ Property Management LLC and add a vessel under the previous Boat Launch Agreement.

4. The resident certifies that the trailered vessels listed herein launch only into Mariaville Lake during a boating season and do not travel to any other waterbody before or after they have first launched into Mariaville Lake.

5. As long as the vessels listed herein have last launched into Mariaville Lake, their owners may use the launch herein without first undergoing the mandatory cleaning process described in Section 6.

6. In the event that any of the vessels listed herein travel to any other waterbody prior to launching into Mariaville Lake, the resident will not allow such vessel to use the launch herein. Rather, such vessel must perform the following prior to launch into Mariaville Lake.

- **Drain**

Empty all water-holding compartments, including the bilge, live wells, and ballast tanks

- **Dry**

Ensure that the boat, trailers, and equipment are completely dry before using them in another body of water

- **Disinfect**

Use high-pressure, hot water that's at least 140°F to disinfect anything that came into contact with water.

7. JAZ Property Management shall secure the launch to prevent trailered vessels from unlawfully using this facility launch. JAZ Property Management agrees to secure the launch in the following manner:

8. Failure to abide by the terms of this agreement will result in residents' revocation of right to use the Boat Launch.

9. I hereby affirm that the information on this form submitted herewith is true to the best of my knowledge and belief. I hereby consent to the JAZ Property Management LLC and their assigns entering upon and passing through this property in order to inspect without prior notice any vehicle or boat being launched for violation of item #6.

10. I hereby agree that at the end of the boating season and no later than Dec1, I will turn in my Boat Launch Key to the MCA at a designated location to be determined at a later date. Failure to turn in the key will result in revocation of right to use the Boat Launch in future years.
